## SUBMISSION PROCESS:

All entries will be submitted electronically at [www.OnlineJuriedShows.com](http://www.OnlineJuriedShows.com). Entry form must be filled out in its entirety. List sizes up to the nearest inch including frame. If framed, must include overall frame size. Submitted images must not include matting or frame. Crop the photos to include only the artwork. Be sure your images are right-side-up. Before uploading images, make sure they are smaller than 4MB, but at least 1920 pixels on the longest side at 72 dpi. Images should be in JPG format, RGB color space. All 2D and 3D media considered. Artwork must have been created within past 3 years. Artwork must be original and not previously exhibited at Front Porch Gallery. Artwork must be ready to hang with proper hanging device.

Size of work limited to 70" on length side, 72" on height side -including frame. Weight limit is 70 pounds.
